is the Commission proposal for an **initial € 100 billion** research and innovation funding programme for seven years (2021-2027)



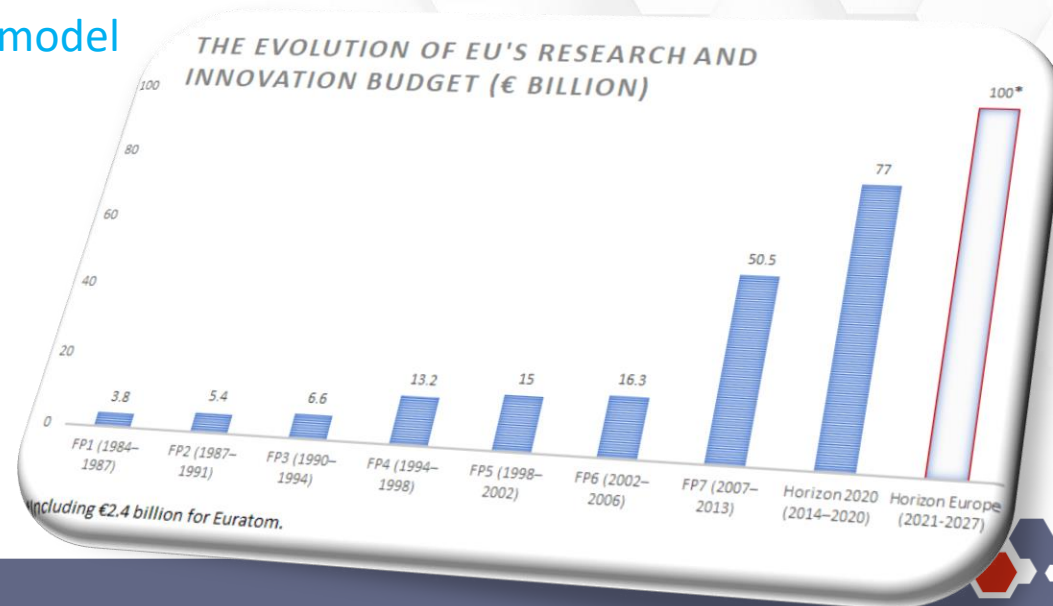

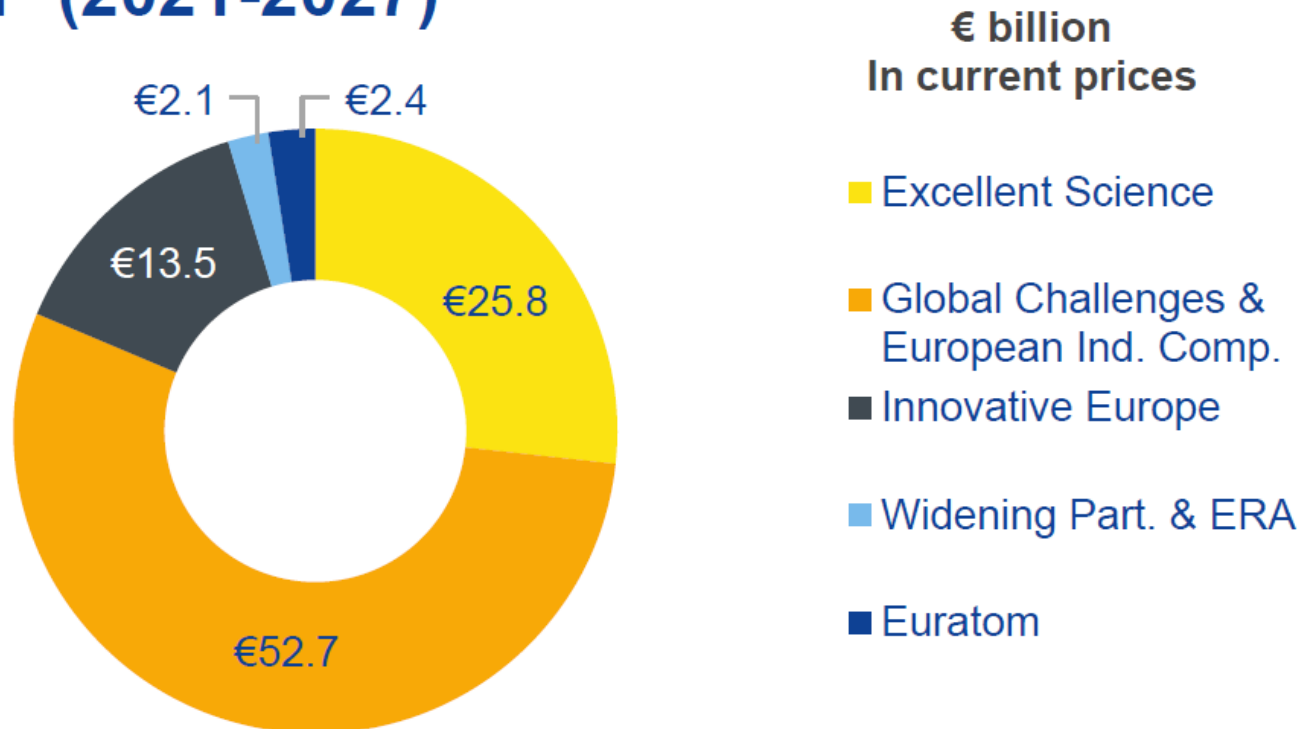

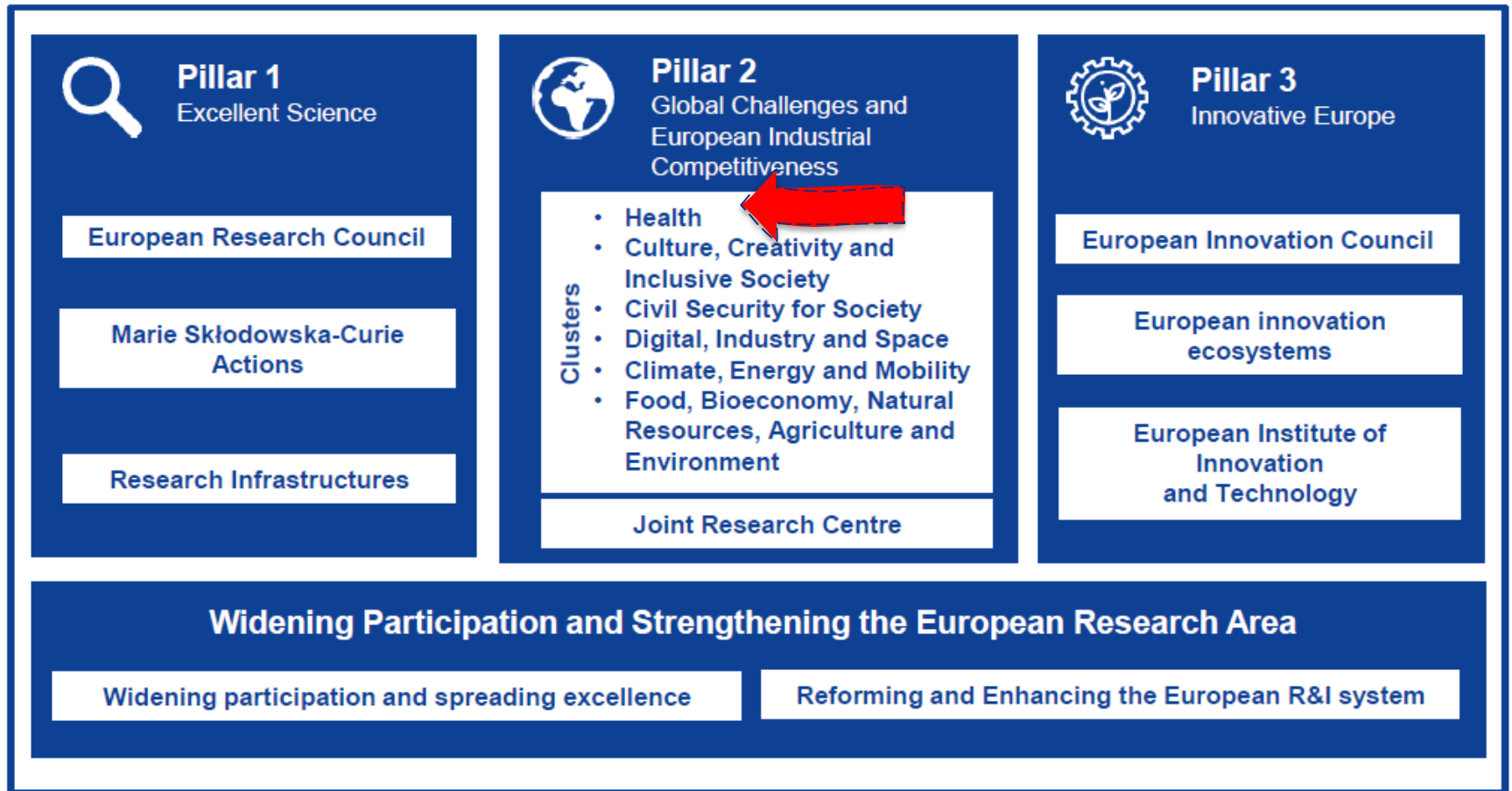

Horizon EUROPE | Overview

Major funding instruments / actions for topic related calls:

- **RIA – Research and Innovation Action**

- Actions work on basic research and development (new knowledge, real data, feasibility of new solutions)
- Funding up to 100 % of direct costs

- **IA – Innovation Action**

- Actions are aimed at the development of a product/process & services. For this, prototypes, demonstration actions and pilots are designed, the product is tested and brought to market
- Funding up to 70 % of direct costs for „for-profit“ organisations, up to 100% for non-profit organisations (RTD, public)

- **CSA – Coordination and Support Action**

- Actions consisting primarily of accompanying measures such as standardisation, dissemination, awareness-raising and communication, networking, coordination or support services, policy dialogues and mutual learning exercises and studies, ... in different countries.
- Funding up to 100 % of direct costs



Horizon EUROPE | Overview

Major funding instruments / actions for open topic calls:

- **Marie Curie Actions**

- Equipping researchers with new knowledge and skills through mobility and training
- Funding via country specific lump sums

Further instruments:

- Innovation and market deployment actions (IMDA)
- Pre-commercial procurement (PCP)
- Public procurement of innovation solutions actions (PPI)



Horizon EUROPE | Rules to participate

- **3 out of 3 rule:** 3 independent organisations from 3 different countries (EU Member states, Horizon Europe associated states) (new: min. 1 EU Member state to be involved)
- Participation of **Non-EU countries:** possible
- **Funding of Non-EU countries:** only for specific countries (low-middle income countries),
China: funding only by Chinese MOST agency if mentioned in the call (which means bilateral contract existis for the specific call topic)
- **Participants:** legal persons, RTD, industry, SME, non-profit, public organisations, international European research organisations



Horizon EUROPE | Application Process

Proposal submission:

- **Full-stage proposal** : The complete proposal will be submitted with the whole set of requested topics of the call text.
- **Two-Stage proposal**: A short proposal (max.10 pages) will be submitted in a first stage including limited chapters and details. After a positive evaluation the invitation for a full stage proposal is needed to continue.
- **Calls are topic related or some are Bottom up = no specific topics**



Horizon EUROPE | Application Process

- Deadline: Date xy; Time: 17:00 CET/CEST (Brussels Time)
- Online Submission of applications (paperless) on [Funding & tenders](#) portal

Necessary:

- Registration on Portal: PIC number (declared for submission, validated for running projects)

Coordinator enters the consortium partners to the launched online proposal (PIC number and contacts at organisation)

Proposal is uploaded as pdf and submitted to EC within deadline.

Max 5 months after deadline: evaluation ended

> decision: in case of success: start of grant agreement preparation phase (max 3 months)
